Title: Expeditionary Airfield and Emergency Services Officer

1. Duties Performed: Expeditionary Airfield and Emergency Services Officers conduct planning for and oversee the installation, operation, and maintenance of expeditionary airfield equipment ISO MAGTF and Installation training and operations. They will lead/oversee Marines in the installation of airfield surfacing, expeditionary visual landing aids, and aircraft recovery equipment. In addition, the 7002 plans for and directs Expeditionary Firefighting and Rescue (EFR) services while deployed ISO MAGTF operations, which includes development and implementation of fire prevention and structural fire response planning. While in garrison the 7002 is the Aircraft Recovery and Aircraft Rescue Fire Fighting (ARFF) Officer in Charge at Marine Corps Air Stations. The Expeditionary Airfield and Emergency Services Officer will act as the Incident Commander for aircraft emergencies, structural fires, rescue operations, and hazardous materials response.

2. Requirements/Pre-requisites: The 7002 MOS may only be assigned to enlisted personnel who are currently qualified in the 7011 (Expeditionary Airfield Technician) or 7051 (Expeditionary Firefighting and Rescue) MOS. Applicants being considered for selection to Warrant Officer in MOS 7002 must have completed either the Marine Expeditionary Airfield Equipment Course (MOS 7011) conducted at NAS Pensacola, FL or the Fire Protection Apprentice Course (MOS 7051) conducted at Goodfellow AFB, San Angelo, TX.

3. Example Billet Descriptions:

Marine Wing Support Squadron (MWSS / WO-CW02)

- Manage all MWSS Expeditionary Airfield (EAF) and Expeditionary Firefighting and Rescue (EFR) assets and personnel deployed and in garrison
- Coordinate the activities of Wing personnel engaged in the design, installation, operation, and certification of all EAF/EFR equipment
- Consolidate verify and insure the timely submission of all EAF/EFR reports
- Design airfield configurations and enhancements, to meet tactical, geographical and environmental conditions for optimum utilization of assets.
- Conduct analysis and direct the placement of emergency service equipment and personnel considering requirements and associated risk
- Supervise the management and preparation of the EFR budget (Green Dollar) and Expeditionary Airfield budget (Blue Dollar) and track all TBA/TE assets
- Advise the commanding officer in all matters pertaining to EAF/EFR

Marine Corps Air Station (MCAS / WO-CW03)

- Directs the activities of the Aircraft Rescue and Fire Fighting organization, including related emergency services based on mission.
- Directs the activities of the Aircraft Recovery organization, including installation, operation and maintenance of equipment.

- Ensure ARFF/Station Recovery personnel and equipment is in a high state of readiness to support all aircraft operations. Immediately notify the Airfield Operations Officer of any case where requirements can't be met
- Supervise all sections within ARFF/Station Recovery IOT ensure efficiency
- Manage the assignment of Marines within the division and ensure quality MOS and required Marine Corps training is complete
- Ensure ARFF/Station Recovery is in compliance with all NAVAIR, NATOPS and requisite NFPA, DOD and OSHA requirements
- Supervise the management and preparation of the ARFF/Station Recovery budget
- Make liaison with outside agencies and inspect all outgoing correspondence

Marine Air Wing (MAW / CWO3-CWO4)

- Advise MAW AC/S Aviation Ground Support Department on all Expeditionary Airfield (EAF) and Expeditionary Firefighting and Rescue (EFR) matters.
- Manage all EFR and EAF assets within the MAW
- Perform duties as Marine Air Wing NATOPS Officer for EAF and EFR
- Perform duties as Functional Area inspector for EAF and EFR
- Prepare/submit all required reports for EAF/EFR to MARFOR via MEF
- Serve as MAW's voting member on the EAF/EFR Senior Leadership Council
- Monitor annual budget requirements for MAW EAF and EFR units
- Monitor/regulate annual training requirements for MAW EAF/EFR Marines
- Represent MAW on all matters pertaining to EAF and EFR
- Conduct Airfield site surveys in support of MAW operations
- Determine EAF/EFR capabilities in support of MAW operations

Marine Expeditionary Force (MEF CWO3-CWO4)

- Maintain Fire Protection Prevention (FP&P) program for all bases in MNF-W
- Act as principal adviser to CG in matters pertaining to FP&P and LOGCAP FF
- Conduct assessments of all bases within the AO in order to make recommendations as to the level of fire protection support required
- Assist/train the designated FOB fire wardens in the implementation of their respective fire protection prevention program and requisition of FOB FF equip
- Conduct semiannual inspections of all FOBs to ensure proper fire safety and the implementation of the MEF Fire Protection and Prevention Program.
- Receive/manage reports and spreadsheets in order to analyze/identify hazard trends and recommend mitigation measures. Generate Fire Marshal Roll-up
- Conduct fire/safety investigations as required, assist MNF/W Safety Office
- Conduct/coordinate all FOB fire protection and training requirements

*Billet Descriptions not listed include: Chemical Biological Incident Response Force (CBIRF) Future Plans Officer (CWO3) and Rescue Platoon OIC (CWO2), OIC Expeditionary Airfield and Equipment Course (EAF School / CWO2), Liaison Officer DoD Fire Academy (ARFF School / CWO3), MARFORPAC G-3 EAF/EFR Officer (CWO4), HQMC AVN EAF/EFR Officer (CWO5), CD&I EAF/EFR Capabilities Integration Officer (CWO4), and PMA-251 EAF Liaison Officer (CWO5).

6. Miscellaneous: The transition from enlisted MOS 7011 or 7051 to Warrant Officer MOS 7002 is an extremely challenging one. The Warrant Officer assumes overall responsibility for the capabilities provided by two separate and un-related MOSs. Both MOSs are highly technical, and each has its own independent training, budgeting, and reporting requirements (Green/Blue Dollar). Candidates who have successfully held varied billets within their respective MOS and have the ability/desire to seek higher education are desired. Expeditionary Airfield and Emergency Services Officers will be a source of expertise on all aspects of EAF/EFR and must be able to communicate their knowledge of MWSS/Station operations and training. They must exhibit maturity, sound judgment, and integrity. Superior oral and written communication skills with a demonstrated ability to teach, coach, and mentor are instrumental.
