PRIVACY ACT STATEMENT

AUTHORITY: 10 U.S.C. 5042, Headquarters, U.S. Marine Corps; 5 U.S.C. 301, Departmental Regulations; and E.O. 9397 (SSN) as amended; and SORN M01133-3.

PURPOSE(S): To certify that the applicant acknowledges and understands all expectations of him/her upon enrollment in an Officer Program in the United States Marine Corps. This service agreement binds the individual to the terms set forth in the agreement upon signature.

ROUTINE USE(S): This information will be accessed by recruiters and DON officials with a need to know in support of requests for enlistment in the U.S. Marine Corps. Information may also be released to officials and employees of other departments and agencies of the Executive Branch of government, upon request, in the performance of their official duties related to the management of quality military recruitment and the recruitment of Marine personnel.

DISCLOSURE: Voluntary; however, failure to provide the requested information may result in an inability to process the individual for enlistment.

1. In connection with my application for enrollment in the **MARINE OPTION NAVAL RESERVE OFFICERS TRAINING CORPS RESERVE (NROTC-R) GROUND** program of the United States Marine Corps (USMC), I hereby acknowledge that:

a. Final approval of my application for enrollment in the **MARINE OPTION NROTC-R GROUND** program as an officer candidate will be determined by the Commandant of the Marine Corps (CMC).

b. Upon reporting for training to Officer Candidates School (OCS), I will be required to participate in training for a minimum of four (4) weeks, regardless of assignment to either a 6-Week Pre-Commissioning, or 10-Week Commissioning Program, unless sooner disenrolled for cause, before any voluntary request for disenrollment will be considered.

(1) If I am disenrolled from OCS and not recommended for future attendance by the Commanding Officer of OCS, I will be conditionally retained in the **MARINE OPTION NROTC-R GROUND** program and have the opportunity to return to OCS if recommended by my command and approved by CMC.

(2) If I am disenrolled from OCS but recommended for future attendance by the Commanding Officer of OCS, I will have the opportunity to reapply to attend OCS through my unit.

(3) If I voluntarily disenroll from OCS at any time during the course of training, I will also be disenrolled from the **MARINE OPTION NROTC-R GROUND** program.

c. I am entitled to pay and allowances while attending OCS not less than those prescribed for a midshipman in United States Code, Title 37, Section 203c.

d. Upon satisfactory completion of all commissioning requirements, I understand that I must choose to either accept or decline a commission if one is tendered to me, and that deferred acceptance is not authorized.

e. A commission in the USMCR is held at the pleasure of the President of the United States.

f. Upon acceptance of a commission, I will incur a Military Service Obligation (MSO) of eight (8) years in the USMCR from the date of appointment to commissioned grade;

g. A minimum of seventy-two (72) months will be in a Selected Marine Corps Reserve (SMCR) unit and any remainder of my service agreement will be served as a member of a SMCR unit, the Individual Ready Reserve (IRR), or as an individual Mobilization Augmentee (IMA).

h. A resignation of my commission submitted prior to completion of this eight (8) year period will normally be rejected and, after this period, may be accepted or rejected by the President, as the needs of the service may then require.

i. Upon successful completion of OCS and acceptance of appointment to commissioned grade, I will be assigned the primary Military Occupational Specialty (MOS) 8001 (Ground) and further be assigned to The Basic School (TBS) for commissioned officer training.

j. Upon successful completion of TBS I will be further assigned to a follow-on Military Occupational Specialty (MOS) School and my assignment will be based upon the SMCR unit(s) and MOS available prior to my assignment to MOS training.

k. United States Code, Title 10, Chapter 39, Sections 671a and 671b currently provide as follows:

(1) 671a. Members: service extension during war. Unless terminated at an earlier date by the Secretary concerned, the period of active service of any member of an armed force is extended for the duration of any war in which the United States may be engaged and for six months thereafter.

(2) 671b. Members: service extension when Congress is not in session

(a) Notwithstanding any other provision of law, when the President determines that the national interest so requires, he may, if Congress is not in session, having adjourned sine die, authorize the Secretary of Defense to extend for not more than six months enlistment, appointments, periods of active duty, periods of active duty for training, periods of obligated service, or other military status, in any component of the armed forces, that expire before the thirtieth day after Congress next convenes or reconvenes.

(b) An extension under this section continues until the sixtieth day after Congress next convenes or reconvenes or until the expiration of the period of extension specified by the Secretary of Defense, whichever occurs earlier, unless sooner terminated by law or Executive order.

1. Federal statutes and pertinent regulations applicable to personnel in the USMC may change without notice. Such changes may affect my status as an officer candidate or commissioned officer and obligations to serve as such.

2. I consent to serve the following minimum periods of duty as a commissioned officer, and understand that a request for release from active duty prior to completion of this period will normally be rejected.

a. I will serve seventy-two (72) consecutive months in a SMCR unit from the completion of MOS school.

b. After successfully completing the seventy-two (72) month obligation in a SMCR unit, I will complete the remainder of my service agreement in a SMCR unit, the IRR, as an IMA; or as the needs of the service may then require.

c. I understand that participation in any Marine Corps incentive program may incur additional obligated SMCR service.

3. I consent to serve one of the following contract options:

a. I have been advised of the MOSs that are available in the vicinity of my City/State. I will be assigned a primary MOS based on the needs of the USMCR. I understand I may elect to waive my geographic preference at any time prior to completion of TBS. I also understand that failure to complete my initial active duty for training due to injury, leadership failure, or academic failure may result in my minimum period of duty assigned to an SMCR unit, cited in paragraph 2(a) of this Service Agreement, being extended beyond forty-eight (48) months to account for the additional period of time needed to successfully complete all required training.

b. I have been advised of the MOS that are available in the SMCR. I hereby waive my geographic preference and request that I be assigned a primary MOS and SMCR unit based on the needs of the SMCR. I also understand that failure to complete my initial active duty for training due to injury, leadership failure, or academic failure may result in my minimum period of duty assigned to an SMCR unit, cited in paragraph 2(a) of this Service Agreement, being extended beyond forty-eight (48) months to account for the additional period of time needed to successfully complete all required training.

4. I have been advised that if I am assigned to a deploying SMCR unit or volunteer to deploy with a deploying SMCR unit I am authorized a voluntary twelve (12) month period pre-mobilization of Active Duty Operational Support (ADOS) following completion of MOS school. These Headquarters Marine Corps funded ADOS orders are to be initiated within eighteen (18) months of completion of my MOS school.
